## TRUTHFULNESS SCALE: LOW RISK RANGE RISK PERCENTILE:10

This is a Low Risk (zero to 39th percentile) score and other scale scores are accurate. Denial, minimizing and faking are minimal. This person was open, honest and truthful. And, this client has adequate reading skills. The Truthfulness Scale identifies self-protective, recalcitrant and guarded people who minimize or conceal information.

## ALCOHOL SCALE: PROBLEM RISK RANGE RISK PERCENTILE:84

This is a Problem Risk (70 to 89th percentile) score. Alcohol use or abuse is a focal issue. Either an established pattern of drinking is evident, or this person is "recovering" (alcohol problem, but has stopped drinking). Relapse is possible. Clarify this person's history and pattern of drinking. With regard to alcohol, this is a Problem Risk score.

## DRUGS SCALE: PROBLEM RISK RANGE RISK PERCENTILE:72

This is a Problem Risk (70 to 89th percentile) score. Drug use or abuse is indicated and may be a focal issue in this client's adjustment problems. Either this person is "recovering" (drug problem, but has stopped using) drug user, or this client manifests an established pattern of drug abuse. Relapse is possible. This is a Problem Risk Drugs Scale score.

## DISTRESS SCALE: PROBLEM RISK RANGE RISK PERCENTILE:73

This client's Distress Scale score is in the Problem Risk (70 to 89th percentile) range. Moods likely vary from agitated to despondent. Distress is affecting this person's adjustment. Symptoms include unhappiness, discontent, worry, anxiety, apprehension and depression.

## RESISTANCE SCALE: MEDIUM RISK RANGE RISK PERCENTILE:50

This person's score is in the Medium Risk (40 to 69th percentile) range. Although typically cooperative, stress, substance abuse or perceived threat can exacerbate defensiveness, uncooperativeness and resistance. This person functions best with clearly understood behavioral expectations and consequences.

## SELF-ESTEEM SCALE: MEDIUM RISK RANGE RISK PERCENTILE:56

This client's self-esteem is relatively intact. Although generally positive self-esteem is indicated, some ambivalence or indecisiveness regarding "self" is becoming evident. Self-esteem reflects an explicit valuing and appraisal of oneself with ambivalent "approval" versus "disapproval" features. This is a Medium Risk Self-Esteem Scale score.

## STRESS COPING SCALE: MEDIUM RISK RANGE RISK PERCENTILE:61

This is a Medium Risk (40 to 69th percentile) range score. Stress is not a focal issue in this client's adjustment. Symptoms of stress can include irritability, moodiness, substance (alcohol and other drugs) abuse, and interpersonal conflict. With regard to stress coping abilities, this is a Medium Risk score.
