## TRUTHFULNESS SCALE: LOW RISK RANGE RISK PERCENTILE:39

This is an accurate PI profile and other PI scale scores are accurate. This individual responded to the test items in a non-defensive, cooperative and truthful manner. Denial and distortion are minimal. This person has adequate reading skills and was truthful. The Truthfulness Scale is designed to identify self-protective, recalcitrant and guarded people who minimize or even try to conceal self-report information.

## VIOLENCE SCALE: MAXIMUM RISK RANGE RISK PERCENTILE:91

Violent tendencies are indicated and a pattern of violence may be well established. This person could be dangerous to self or others. Violent behavior is characterized by ruthlessness, savageness, destructiveness and explosiveness. Substance abuse, jealousy and perceived stress could escalate violent behavior. This person would likely be intimidating, threatening, and potentially brutal or dangerous. This is likely a violent person. Prior violence is also likely.

## ANTISOCIAL SCALE: PROBLEM RISK RANGE RISK PERCENTILE:85

An established pattern of antisocial behavior is evident. Problem risk is characterized by many antisocial behaviors and difficulty maintaining responsible relationships and loyalties. These individuals are frequently callous, irresponsible, and lack a foundation of mutual affection or trust. Many are boastful, deceitful and given to tantrums or outbursts of rage. Poor work histories, nonpayment of bills and difficulty conforming to social norms are common. Problem risk score.

## ALCOHOL SCALE: MEDIUM RISK RANGE RISK PERCENTILE:68

Alcohol (beer, wine or liquor) use or possible abuse is present. Frequent drinking, weekend abuse or binge (episodic) drinking could indicate a potential problem. RECOMMENDATIONS: Important areas of inquiry include history and pattern of drinking. Prior alcohol-related offenses would upgrade risk considerably. If alcohol risk is upgraded, options include: alcohol-oriented educational program, Alcoholics Anonymous (AA), or possibly counseling. With regard to the Alcohol Scale, this is a medium risk score.

## DRUGS SCALE: MEDIUM RISK RANGE RISK PERCENTILE:69

An established pattern of drug use or abuse is not evident, however, there may be a "proneness" toward drug use or abuse. Drug use may be experimental or historical. RECOMMENDATIONS: Important areas of inquiry include the client's history and pattern of drug use. Participation in Narcotics Anonymous (NA), Cocaine Anonymous (CA) or a drug-oriented educational program might be helpful. With regard to the Drugs Scale, this is a medium risk score.

## DISTRESS SCALE: PROBLEM RISK RANGE RISK PERCENTILE:79

This parolee's Distress Scale score is in the Problem Risk (70 to 89th percentile) range. Distress incorporates both anxiety and depression and represents the most common reason for seeking counseling. Distress is contributing to the parolee's emotional and adjustment problems. RECOMMENDATIONS: This is a troubled parolee that needs to talk to somebody about existing problems and concerns. Counseling or

group therapy might help. Symptoms include uneasiness, unhappiness, growing apprehension and varying degrees of frustration.

SELF-ESTEEM SCALE: MAXIMUM RISK RANGE

RISK PERCENTILE:90

The presence of pervasive negative self-evaluations, negative expectations, and disapproval of oneself represents a focal area of difficulty for this parolee. Emotional and social isolation are likely and considerable sensitivity to rejection or perceived threat is evident. This is an unhappy person. With regard to the Self-Esteem Scale, this is a high risk score. Referral to a certified/licensed mental health professional might be considered.

STRESS COPING SCALE: PROBLEM RISK RANGE

RISK PERCENTILE:79

Stress coping abilities are not well established. Stress is likely a focal area of concern. This person is not coping effectively with stress, tension, anxiety or pressure. Symptoms of stress include irritability, depression, marital/family problems, impaired concentration and in some cases even substance abuse. Stress is contributing to emotional and adjustment problems. This is a problem risk Stress Coping Abilities Scale score.
